Construction Products Regulation

Dear Sir/Madam,

The Construction Products Regulation (CPR) as per EN 50575:2014 (*Power, control and communication cables - Cables for general applications in construction works subject to reaction to fire requirements*) came into effect on 1st June 2016. At the end of the transitional period on 1st June 2017, this regulation becomes mandatory for all cables and wires permanently attached to buildings, either in plaster or installation ducts.

HELUKABEL® GmbH is getting ready for the mandatory introduction of the new regulations and is accordingly revising the affected products in order to be able to provide a product assortment with the necessary certifications. We working on preparing the products for testing and certification at the notified bodies. At the end of the transitional period, we shall be in a position to ship CE-marked products which are in conformity with the corresponding declaration of performance, as per the CPR.
